FOURTH AMENDMENT
TO
DECLARATION OF CONDOMINIUM
YARMOUTH BLUFFS CONDOMINIUMS
BY

POTTER-LEWIS BUILDERS, INC.

(Dated December 31, 1985, and recorded in the Cumberland County Registry of Deeds in Book 7029, Page 168, and Book 7031, Page 317, as amended.)

Pursuant to Section 1602-110 of the Maine Condominium Act and Section 2 of Declaration of Condominium, Yarmouth Bluffs Condominium, dated December 31, 1985, and recorded in Cumberland County Registry of Deeds in Book 7029, Page 168, and Book 7031 and Page 317, as amended by an Amended Declaration dated September 24, 1986, and recorded in said Registry in Book 7394, Page 345, and as amended by Third Amendment dated May 28, 1987, and recorded in said Registry of Deeds in Book 7791, Page 184, said Declaration is hereby further amended as follows:

1. Amend the second paragraph of Section 1, as amended by Amendment to Declaration (dated 9/24/86) and as amended by Third Amendment (dated May 28, 1987), to read:

A properly prepared and certified plat of the land and plans of the units created by the Declaration were recorded simultaneously with the Declaration in Plan Book 147, page 27, and [152-52]. A properly prepared and certified plat of the land and plans of the units created by Amendment to the Declaration (dated 9/24/86) were recorded simultaneously with Amendment to the Declaration (dated 9/24/86) in Plan Book 158, page 8. A properly prepared and certified plat of the land and plans of the units created by Third Amendment (dated 5/28/87) were recorded simultaneously with Third Amendment (dated 5/28/87) in Plan Book 162, Page 50, in the Cumberland County Registry of Deeds. A properly prepared and certified plat of the land and plans of the units created by this Fourth Amendment (dated 11/12/87) are recorded simultaneously with this Fourth Amendment (dated 11/12/87) in Plan Book 166, Page 61, in said Registry of Deeds

2. Amend the first paragraph of Section 2, as amended by Amendment to Declaration (dated 9/24/86) and as amended by Third Amendment (dated May 28, 1987) to read:

Declarant reserves the right to create 54 units, to be numbered 1 through 54, of which 13 units numbered 4 through 8 and 39 through 46, each inclusive, having been previously created by the recordation of the Declaration, of which 11 units numbered 9 through 11 and 47 through 54, each inclusive, having been previously created by the recordation of Amendment to Declaration (dated 9/24/86), of which 15 units numbered 12 through 23 and 28 through 30, each inclusive, having been previously created by the recordation of Third Amendment (dated May 28, 1987), and of which 12 units numbered 24 through 27 and 31 through 38, each inclusive, are hereby created making a total number of units created of 51. The location and boundaries of all 54 units are shown on the plat and plans referred to in Section 1 of the Declaration.

2. Amend Appendix II to read:

NOTE: Allocation of common element interest and common expense liability and voting rights is based upon an equal allocation to all existing units. Variation in the size or relative values of units will not result in a change to these allocations. Addition or withdrawal of units will result in a reallocation based upon the formula of equal allocation to all existing units.

3. The purpose of this amendment is to create an additional twelve (12) units constituting Phase IV.
